Brian R.Owens THE SCULPTOR





Brian R. Owens – Owens belongs to a small fraternity of artists who use classical techniques to depict contemporary subject matter. Within this is an even smaller group: Artists that have won highly competitive grants, scholarships and commissions – both public and private. And within this, a still smaller group: Artists that can both sculpt and paint. From Michigan to Florida; from applied scientist to sculptor; Owens has made an improbable journey into the world of art and the continent of his soul. Owens is known as a sculptor who works mostly on a commission basis. But a closer look reveals his range as a visual artist, including works in oil, acrylic, pastel and pencil.

"Art is not something I do, it's who I am", said Owens. "I didn't choose to be an artist, it chose me.
William H. Gass predicted my own feelings when he said that people like myself are here to add to the world's objects and ideas those delineations, carvings and symphonic spells as ought to already be there. To make things whose purpose is contemplation and appreciation."
